If the county, township, or municipality uses it own vehicles to apply brine, it need not list hauler numbers; however, if hauler delivers the brine to a holding tank prior to application, the hauler's name and registration number must be listed.
- Item IV. Supply requested information for each point from which brine was collected and eventually used for surface application.
