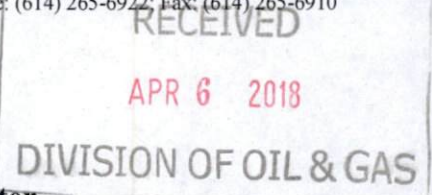

RE: Surface Application Annual Reports (Form 15) Reminder Letter.

To whom it may concern:

Surface Application Annual Report (Form 15) is due on or before the 15th of April, setting for the total volume of production brine spread per each application points during the preceding calendar year. A recipient of an approved surface spreading resolution is required by Section 1509.226(F) of the Ohio Revised Code to file a report with the Division on a yearly basis designating the volume of production brine applied under an active spreading resolution.

To date, the Division has not received 2017 Surface Application Annual Report for your approved resolution. The Surface Application Annual Report (Form 15) is due no later than April 15 for the preceding calendar year.

Even if no brine was spread in 2017 a Form 15 is required to be submitted.

The enclosed form is to be completed and returned to the Division. Failure to submit these reports will be considered a violation of the aforementioned law and may result in additional enforcement action.

An electronic form may be filled out, downloaded and submitted. The Form is located at <http://oilandgas.ohiodnr.gov/electronicforms> under the section labeled Underground Injection Control (UIC) Forms.
